

Brackets for The Cure Contest

Official Rules

Void where prohibited by law. This contest is subject to all applicable federal, state, and local laws.

ELIGIBILITY: This contest is open to legal residents of the United States who are 18 years of age or older at the time of entry and who are registered fundraising participants for the 2021 Brackets For The Cure event on <https://komenneohio.org/ne-ohio-events/brackets-for-the-cure/>. Employees of Susan G. Komen (“Sponsor”) and its respective officers, directors, parents, subsidiaries, affiliates, as well as their immediate family members, are not eligible to enter or win. Participants may need to provide proof of residency. All entries should be submitted in good faith.

HOW TO ENTER: The contest period begins on March 14th and will end on April 6th at 12 pm EST. When you donate \$25 USD or more per bracket on your Brackets for The Cure site during the contest period, you will be entered into the Brackets challenge to compete for prizes for the highest number of points scored in the Men’s Division I NCAA basketball tournament. Scoring and bracket entries will be managed through CBSsports.com. For every bracket entered in the contest, a \$25 donation must be made to validate the entry in the 2021 Brackets for the Cure contest. Individuals may submit an unlimited number of bracket entries, but a \$25 donation must be made for each bracket submitted.

PRIZE DESCRIPTION: The winner who receives the most points by selecting the winners of each round of the Men’s Division I NCAA basketball tournament will receive one (1) \$500 Visa gift card. The second place winner will receive one (1) \$250 Visa gift card, and the third place winner will receive one (1) \$100 Visa gift card.

WINNER SELECTION: All eligible entries submitted during the contest period will be considered during the Men’s Division I NCAA basketball tournament that begins on Friday, March 19th. First, second, and third place finishers will be determined by top points awarded through the CBSsports.com Bracketology app. The top three (3) winners will be determined based on the points received from completing the bracket.

In the event of a tie, CBSsports.com provides the tie-breaker structure for the tournament. All scoring is completed by the CBSsports.com Bracketology app. If more than one eligible participant is tied in the Contest, the participant whose prediction of the total combined points in the bracket is closest to the actual final total combined score will win the prize. If there is still a tie, the participant whose prediction of the total combined points in the bracket is closest to the actual final total combined score, without going over, will win the Prize. If a tie remains, Prize will be split among tied participants.

WINNER NOTIFICATION: The winner will be contacted by email and/or phone with the information provided in their registration on the 2021 Brackets for The Cure site. To claim the prize, the winner must accept within three (3) business days after the first notification by Sponsor. Failure to timely claim the prize will result in disqualification. If a potential winner is disqualified for any reason, Sponsor will award the applicable prize to the next place finisher according to point totals. Once the prize is claimed, Sponsor will mail prizes to the winner within ten (10) business days.

GENERAL TERMS & CONDITIONS: All participants must meet the eligibility requirements set forth in these Official Rules in order to qualify for the prize. By participating, each participant agrees to:

(1) Abide by these Official Rules and decisions of Sponsor, which shall be final in all respects relating to this contest;

(2) Release, discharge and hold harmless Sponsor, and its respective parents, affiliates, subsidiaries, and advertising and contest agencies, and the respective officers, directors, shareholders, employees, agents and representatives; and

(3) Acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding.

If for any reason the contest is not capable of running as planned, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the contest and select winners from among all eligible entries prior to the cancellation. Persons found tampering with or abusing any aspect of the contest, or whom Sponsor believes to be causing malfunction or error, disruption or damage will be disqualified. Sponsor reserves the right to correct any typographical, printing, computer programming or operator errors.

Sponsor is not responsible for any entry that is lost, late, illegible, stolen, mutilated, incomplete, invalid, unintelligible, postage-due, misdirected or undeliverable, whether due to system errors, omissions, interruption, deletions, defects, delay in operations or transmissions, theft or destruction or failures, faulty transmissions or other telecommunications malfunctions, human error, entries not received resulting from any hardware or software failures of any kind, lost or unavailable network connections, failed, incomplete or garbled computer transmissions, typographical or system errors and failures, faulty transmissions, technical malfunctions, or otherwise. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

Prize cannot be resold, traded, or auctioned and has no cash redemption equivalent.

If the actual value of a prize is less than previously stated, the difference will not be awarded. Other restrictions may apply. All prizes are subject to change and/or cancellation. If applicable, an IRS Form 1099 for the fair market value of the prize will be filed and a copy provided to each winner. Each winner must provide Sponsor with his or her social security number so that the Form 1099 can be provided. In connection with any involvement and/or activities related to the prize, each winner does hereby:

(1) Acknowledge and accept sole responsibility for all of the hazards and risks to him/herself and his/her property associated with or related to participation and for any damage, illness, or injury that he/she may cause to others;

Sponsor reserves the right to request from any participant additional documentation it reasonably believes is necessary to validate any entry or to award the prize. Without limitation, Sponsor shall not be liable for any failure to deliver prize due to winner's failure to accept delivery, to meet any of his or her obligations hereunder or due to the submission of any false, inaccurate or misleading information.

YOU HEREBY REPRESENT AND WARRANT THAT YOU HAVE READ THESE OFFICIAL RULES AND ARE FULLY FAMILIAR WITH THEIR CONTENTS.

All judgments or awards shall be limited to actual out-of-pocket damages (excluding attorneys' fees) associated with participation in this contest and shall not include any indirect, punitive, incidental and/or consequential damages.
